As you requested, GZA GeoEnvironmental, Inc. (GZA) has prepared this proposed Scope of Work to assist the New Hampshire Department of Environmental Services (NHDES) with 2021 Site reconnaissance and maintenance activities at the Troy Mills Landfill Superfund Site located in Troy, New Hampshire (Site). The proposed Scope of Work has been developed based on our discussions with NHDES and our understanding of the field activities to be performed. The work will be performed in general accordance with our 2019 to 2023 NHDES Environmental Consulting Services Contract as approved by the Governor and Council on June 5, 2019.

SCOPE OF WORK

The following describes the proposed Scope of Work.

TASK 1 – SITE MAINTENANCE

GZA's field representative will perform a Site reconnaissance to observe and document current conditions at the Site and, as necessary, trim overgrown vegetation around wells and hanging into the access roadways. Our field representative will also replace the Troy Mills Landfill Superfund sign on the north gate of the Site. Prior to the Site reconnaissance, GZA will purchase replacement/back up "No Trespassing" signs and appropriate hardware to affix replacement signs, as necessary.

The budget for this task includes eight hours of field time for travel, preparation of an updated Health and Safety Plan, Site reconnaissance and maintenance, and acquiring signs and hardware.
