Dear Mr. Browne:

The New Hampshire Department of Environmental Services (NHDES) has reviewed the subject report and other information in our files regarding the petroleum discharge discovered on September 20, 1988 at the referenced site. The report meets the requirements of Groundwater Management Permit (GMP) GWP-198904015-H-004. Based on review of the existing information, NHDES notes that petroleum volatile organic compounds (VOCs) persist in site groundwater at concentrations above New Hampshire Ambient Groundwater Quality Standards. To manage site groundwater contamination, please continue the site groundwater quality monitoring program in accordance with the site GMP.

**Facility Compliance and Cost Reimbursement**

A review of our files shows that Global Companies LLC is eligible to be reimbursed by the New Hampshire Petroleum Reimbursement Fund Program (Fund) for costs to implement NHDES-required investigation and remediation related to the petroleum hydrocarbons discharge discovered on September 20, 1988.

To receive reimbursement from the Fund, all work must be pre-approved and conducted in accordance with New Hampshire Code of Administrative Rules Odb-400. NHDES approved a work scope and budget for term-of-permit services on November 29, 2021. 
