The New Hampshire Department of Environmental Services (NHDES) has determined the responsible party identified on the statement to be strictly liable for costs relating to the containment, removal, and assessment of petroleum contamination at the site identified on the invoice.

Under New Hampshire State Law, RSA Chapter 146-A:3-a., any person who, without regard to fault, causes or suffers the discharge of oil, shall be strictly liable for costs relating to the containment and removal of the oil and the cleanup and restoration of the site.

The statement includes, but is not limited to, all NHDES staff costs incurred, during the identified billing period, associated with oversight, review or management of any response or remedial action at the site related to the discharge of oil, for which you have been identified as a responsible party. Non staff costs for the identified billing period, such as DES contractor costs which have not yet been billed, may be included in a later statement.

Because the responsible party for this discharge is eligible to receive reimbursement from the New Hampshire Petroleum Reimbursement Fund (Fund) as outlined in RSA 146-D:6, the costs identified in this statement will be paid directly to NHDES from the Fund; therefore, no action is required on your part.
