- III. MODIFICATION: This permit modification provides conditional approval to vertically and horizontally expand the TLR-III Refuse Disposal Facility in such a manner as to increase its permitted disposal capacity by approximately 15.9 million cubic yards. The horizontal expansion is referred to as Phases 15-17 and the vertical expansion is over previously permitted Phases 1-7 and 9-14, as depicted in the submittals referenced in Section II herein. The combined horizontal and vertical expansion is hereinafter collectively referred to as "the facility expansion".
- IV. TERMS AND CONDITIONS: Attached.
- V. EFFECTIVE DATE: Date of signature below.
- VI. <u>AUTHORIZING SIGNATURE</u>: The permit identified in Section I above is hereby modified as specified in Section III above, subject to terms and conditions provided in Section IV above. This authorization is based on information provided to NHDES by the permittee in documents referenced in Section II above. If the information is false, misleading or incomplete, the modified permit may be revoked or suspended in accordance with Part Env-Sw 306 of the New Hampshire Solid Waste Rules.

BY EXERCISING ANY RIGHTS UNDER THIS PERMIT, THE PERMITTEE HAS AGREED TO ALL TERMS AND CONDITIONS OF THE PERMIT. Failure to comply with the terms and conditions of the permit could result in administrative, civil or criminal enforcement action and penalties, and suspension or revocation of the permit. No liability is incurred by the State of New Hampshire by reason of any approval of this solid waste facility. No warranty/guarantee is intended or implied by reason of any advice given by NHDES or its staff.

This permit shall not eliminate the permittee's obligation to obtain all requisite federal, state or local permits, licenses or approvals, or to comply with all other applicable federal, state, district and local permits, ordinances, laws, approvals or conditions relating to the facility.

#### **Section IV: Terms and Conditions**

# **General Requirements:**

- (1) This facility (Phases 1-17) shall comply with the requirements of the Solid Waste Management Act, RSA 149-M; the New Hampshire Solid Waste Rules (Env-Sw 100 et seq.), as may be amended from time to time; and the terms and conditions of Standard Permit No. DES-SW-SP-95-001 issued on April 10, 1995, and all modifications and approvals thereof, including this permit modification, listed for reference in Appendix A of this modification.
- (2) This permit modification is approved on the basis of information provided by the permittee in the permit modification application documents referenced in Section II and listed for reference in Appendix B of this permit modification, hereinafter collectively referred to as the Permit Modification Application.
- (3) Where conflicts exist between the Permit Modification Application and the terms and conditions of this permit modification, the terms and conditions of this permit modification shall apply.
- (4) The terms and conditions of this permit modification, if in conflict with any other permit modification or approval issued prior to the effective date of this permit modification, shall supersede the earlier provision.

#### **Siting Requirements:**

- (5) Phases 15-17 shall be sited in compliance with the following requirements, as in effect on the issue date of this permit modification:
  - (a) The landfill siting requirements identified in Env-Sw 804, subject to Waiver No. DES-SW-WV-18-002:
  - (b) The universal siting requirements identified in Env-Sw 1003;
  - (c) The additional siting requirements identified in Env-Sw 1102; and
  - (d) All terms and conditions of this permit modification.
- (6) The approved footprint of this facility shall be as shown on plan Sheet No. 21 of the Design Drawings prepared by Sanborn, Head & Associates, Inc., dated May 2017, and entitled "Final Grading Plan", provided in the Permit Modification Application document submitted May 24, 2017 and assigned WMD Log No. 2017-28465-01.

#### **Design Requirements:**

(7) The facility expansion shall be designed in conformance with the preliminary design provided in the Permit Modification Application and in compliance with the requirements in effect at the

time of final design approval including the following:

- (a) The landfill design requirements identified in Env-Sw 805;
- (b) The universal design requirements identified in Env-Sw 1004;
- (c) The additional design requirements identified in Env-Sw 1103; and
- (d) All terms and conditions of this permit modification.
- (8) With the application for final design approval of the mechanically-stabilized earth (MSE) berm that supports the landfill footprint for Phases 15-17, the permittee shall submit:
  - (a) Final design plans and supporting calculations for the MSE berm prepared in accordance with Env-Sw 1103.05; and
  - (b) An MSE berm inspection, monitoring and maintenance plan for all MSE berms at the facility, to be appended to both the Operating Plan and Closure Plan, that includes, as appropriate for the type, design and function of each MSE berm:
    - 1. Identification of the zone of influence of each MSE berm;
    - 2. Visual inspection protocols;
    - 3. Geotechnical instrumentation (e.g., inclinometers, piezometers, settlement plates) monitoring requirements and action levels; and
    - 4. A contingency plan for unacceptable berm performance.
- (9) With the application for final design approval of the first phase or portion thereof of the facility expansion, the permittee shall submit:
  - (a) An affirmation that the permittee owns the property on which Phases 15-17, including the buffer zones required by Env-Sw 804.04, is sited as required by Env-Sw 804.06;
  - (b) A demonstration that Phases 15-17 containment structures, including liners, leachate collection systems, and surface water control systems, are designed to resist the maximum horizontal acceleration in lithified earth material for the site, pursuant to Env-Sw 803.04(a)(1) and 40 CFR Part 258.14;
  - (c) An affirmation that Phases 15-17 are designed to provide the capability to operate in a manner that promotes rapid biological stabilization of landfilled wastes, as required by Env-Sw 805.12(b);
  - (d) A statement identifying the requested approved design capacity of the facility, namely the average weekly tonnage to be received at the facility during the quarter in which the most waste is anticipated to be received, as defined in Env-Sw 102.09(a); and
  - (e) With the updated operating plan, odor control provisions for all operations and construction that involve exposing or removing waste.
- (10) Prior to filing the notice of intent to construct for any liner system, inclusive of final subgrade preparation, in Phases 15-17 or portion thereof, the permittee shall submit a demonstration that the phase or portion meets the requirements of Env-Sw 804.02(d). The demonstration shall be made in accordance with the proposal submitted as part of the Permit Modification Application (ref. WMD Log No. 2017-28465-10, dated January 25, 2018), with the groundwater monitoring period extending from at least September 1 through June 30. During the monitoring period, the permittee shall submit progress reports no less than quarterly.

#### **Construction Requirements:**

- (11) Prior to commencing construction of the facility, or any phase or portion thereof, the permittee shall:
  - (a) Satisfy the requirements of Condition (10) above;
  - (b) Satisfy the prerequisites for construction specified in Env-Sw 1104.01;
  - (c) File a Notice of Intent to Construct in accordance with Env-Sw 1104.02; and
  - (d) Obtain construction approval as specified in Env-Sw 1104.03.
- (12) This facility shall be constructed in accordance with the following requirements:
  - (a) The landfill construction requirements in Env-Sw 805;
  - (b) The additional construction requirements in Env-Sw 1104;
  - (c) All terms and conditions of this permit; and
  - (d) The final design plans and specifications approved for construction.

### **Operating Requirements:**

- (13) Prior to commencing operation of the facility, or any phase or portion thereof, the permittee shall:
  - (a) Satisfy the prerequisites for operations specified in Env-Sw 1105.01;
  - (b) File a Notice of Intent to Operate in accordance with Env-Sw 1105.02; and
  - (c) Obtain operating approval as specified in Env-Sw 1105.03.
- (14) This facility shall be operated in accordance with:
  - (a) The Solid Waste Management Act, RSA 149-M;
  - (b) The New Hampshire Solid Waste Rules, Env-Sw 100-2000, as applicable;
  - (c) The Approved Operating Plan of Record, which on the effective date of this permit modification is the operating plan revised August 6, 2014, received by NHDES on August 12, 2014 (WMD Log # 14072) and approved by NHDES on August 27, 2014;
  - (d) The facility vertical and horizontal limits as shown on plan Sheet No. 21 of the Design Drawings prepared by Sanborn, Head & Associates, Inc., dated May 2017, and entitled "Final Grading Plan", provided in the Permit Modification Application document submitted May 24, 2017 and assigned WMD Log No. 2017-28465-01.
- (15) Prior to January 1, 2021, this facility shall be operated in accordance with the public benefit provisions of the permit modification approved October 8, 2009.
- (16) Starting on January 1, 2021, this facility shall be operated in accordance with the public benefit provisions provided in Condition (21) below.

# (17) Authorized and Prohibited Wastes:

- (a) <u>Authorized Wastes</u>: Subject to (b) below, this facility is authorized to landfill the following types of solid waste only:
  - 1. Municipal solid waste, as defined in Env-Sw 103.47;
  - 2. Construction and demolition debris, as defined in Env-Sw 102.42;
  - 3. Bulky waste, as defined in Env-Sw 102.23;
  - 4. Bottom ash, as defined in Env-Sw 102.22, and fly ash, as defined in Env-Sw 103.04;
  - 5. Asbestos waste, as defined in Env-Sw 102.14;
  - 6. Infectious waste, as defined in Env-Sw 103.28, treated to achieve the standard specified in Env-Sw 904.03(a);
  - 7. Solid wastes listed below that have been determined to be non-hazardous pursuant to the New Hampshire Hazardous Waste Rules (Env-Hw 100 et seq.) and which have been profiled and approved through the permittee's approval process identified in the Approved Operating Plan of Record.
    - a. Sludge and septage solids for which alternative management options, such as composting, landspreading and/or incineration are not available or appropriate for identified reasons;
    - b. Waste from industrial processes;
    - c. Waste from pollution control devices;
    - d. Residue from a spill of non-hazardous chemical substance or commercial product or an authorized waste listed herein;
    - e. Contaminated residuals from the clean-up of a facility generating, storing, treating, recycling, or disposing wastes, chemical substances, or commercial product wastes listed above;
    - f. Commercial products which are off-specification, outdated, or unused;
    - g. Waste produced from the demolition or dismantling of industrial process equipment or facilities contaminated from the industrial process;
    - h. Soils and other media with contamination, as defined in Env-Or 602.07, that are not regulated as hazardous waste; and
    - i. Other non-hazardous waste not specifically listed above that has the potential to be hazardous so as to require completion of a hazardous waste determination prior to acceptance, or that requires special handling so as to require the additional measures specified in the Approved Operating Plan of Record prior to acceptance.
  - 8. Other non-hazardous, non-recyclable solid waste not specifically listed above, subject to written approval from NHDES based on information provided by the permittee that identifies the source, type, quantity, age if known, physical characteristics, and analytical characteristics of the waste.
- (b) Prohibited Wastes: This facility is not permitted to landfill:
  - 1. Hazardous waste as defined by RSA 147-A:2 and the New Hampshire Hazardous Waste Rules (Env-Hw 100 et seq.), including hazardous waste from out-of-state conditionally exempt small quantity generators;

- 2. Polychlorinated biphenyls (PCBs) that are regulated under the Toxic Substances Control Act, as amended (ref. 40 CFR Part 761);
- 3. Chlorofluorocarbons (CFCs), as prohibited by Title 6 of the Clean Air Act, as amended (ref. 40 CFR Part 82);
- 4. Infectious waste, as defined in Env-Sw 103.28, that has not achieved the standard specified in Env-Sw 904.03(a);
- Contained gaseous waste;
- 6. Liquid waste (i.e., waste deemed to contain "free liquids" as determined by Method 9095B, *Paint Filter Liquids Test*, described in "Test Methods for Evaluating Solid Wastes: Physical/Chemical Methods Compendium", EPA Pub No. SW-846), except leachate recirculated in accordance with the Approved Operating Plan of Record;
- 7. Wet cell batteries, pursuant to RSA 149-M:27,II;
- 8. Leaf or yard waste, pursuant to RSA 149-M:27,III;
- 9. Video display devices, central processing units from computers, or non-mobile video display media recorders or players, pursuant to RSA 149-M:27,IV;
- 10. Mercuric oxide batteries, pursuant to RSA 149-M:28,IV;
- 11. Mercury-added products, pursuant to RSA 149-M:58,I;
- 12. Radioactive materials as defined and regulated by the New Hampshire rules for the control of radiation, He-P 4000; and
- 13. Any other waste that is prohibited from disposal in a solid waste landfill under RSA 149-M, Env-Sw 806.12, or any other state or federal regulation.

#### Closure Requirements:

- (18) The permittee shall close and provide post-closure inspection, maintenance and monitoring of this facility in accordance with:
  - (a) The Solid Waste Management Act, RSA 149-M;
  - (b) The New Hampshire Solid Waste Rules, Env-Sw 100-2000, as amended;
  - (c) The Approved Closure Plan of Record, which on the effective date of this permit modification is the Closure Plan received by NHDES on September 8, 2008 and October 9, 2008 (WMD Log Nos. 200800139 and 200800159) and approved by NHDES on October 16, 2008; and
  - (d) The facility vertical and horizontal limits as shown on plan Sheet No. 21 of the Design Drawings prepared by Sanborn, Head & Associates, Inc., dated May 2017, and entitled "Final Grading Plan", provided in the Permit Modification Application document submitted May 24, 2017 and assigned WMD Log No. 2017-28465-01.
- (19) Prior to construction of the capping system or any portion thereof, the permittee shall submit and obtain approval of final design plans and specifications for constructing the capping system or the relevant portion thereof, prepared on the basis of the preliminary design plans provided in the Approved Closure Plan of Record.

#### **Financial Assurance:**

- (20) The permittee shall provide and continually maintain financial assurance in accordance with:
  - (a) The Solid Waste Management Act, RSA 149-M;
  - (b) The New Hampshire Solid Waste Rules, Env-Sw 100-2000, as amended; and
  - (c) The approved Financial Assurance Plan, which on the effective date of this permit modification is the Financial Assurance Plan received by NHDES on September 23, 2016, February 16, 2017, and March 7, 2017 (WMD Log Nos. 2016-24185-01, 2016-24185-02, 2016-24185-03) and approved by NHDES on March 22, 2017.

#### Determination of Public Benefit:

- (21) It is the determination of NHDES under RSA 149-M:11,X that operation of this facility provides a substantial public benefit, as required by RSA 149-M:11,III and IV, when facility operations, starting on January 1, 2021 as specified in Condition (16), conform to the following conditions:
  - (a) The permittee shall limit airspace use to 1.55 million cubic yards per year averaged over a rolling three consecutive years.
  - (b) The permittee shall operate the facility through at least June 30, 2034.
  - (c) The permittee shall make available disposal capacity for New Hampshire generated solid waste for the entire operating life of the facility.
  - (d) The permittee shall, for each calendar year in which the facility operates:
    - 1. Demonstrate that the sources, in aggregate, from which the permittee accepted municipal solid waste (MSW) and/or construction and demolition (C&D) debris for disposal achieved a minimum 30 percent waste diversion rate to more preferred methods than landfilling as outlined in the hierarchy in RSA 149-M:3. If a minimum 30 percent diversion rate cannot be demonstrated, then the permittee shall submit to NHDES by July 1 of the following year a waste diversion report which presents the permittee's evaluation of:
      - a. The actual MSW and C&D debris waste diversion rate achieved;
      - b. The primary factors affecting that diversion rate; and
      - c. The practicable measures that the permittee will undertake to improve the diversion rate and an implementation schedule for doing so.
    - 2. The demonstration under Condition (21)(d)1 above shall not be required to include certain sub-types of MSW and C&D debris waste based upon a demonstration by the permittee that there are no environmentally safe or economically sound diversion alternatives to landfilling such wastes.
  - (e) The permittee shall assist 15 or more New Hampshire solid waste generators per year with establishing or improving programs that assist in the implementation of the goals and hierarchy under RSA 149-M:2 and RSA 149-M:3, respectively.

# **Additional Submittals Required:**

- (22) No later than December 11, 2018, the permittee shall submit to NHDES:
  - (a) An evaluation of its existing communication practices with the public regarding landfill nuisances, including reports of noise and odor, and recommendations to improve communication with the public.
  - (b) A report regarding noise at the facility, certified by a third-party professional engineer licensed in New Hampshire. The report shall include the following:
    - 1. An evaluation of the methods currently used at the facility to control noise; and
    - 2. Identification of deficiencies or issues related to the noise control methods, and proposed recommendations and solutions for minimizing noise.
