

# 2019 Annual Report

# Saco-Swift Rivers Local Advisory Committee P.O. Box 268, Jackson, NH 03846

The Saco-Swift Rivers Local Advisory Committee represents the towns of Albany, Bartlett, Conway, Hart's Location, Jackson, Livermore, and Waterville Valley, in addition to the White Mountain National Forest and Crawford Notch State Park, on issues pertaining to the Swift and Saco river corridors, which are designated for special oversight and protection by the State of New Hampshire.

#### Introduction

The Saco-Swift Rivers Local Advisory Committee (SSRLAC) is pleased to present this report summarizing the group's 2019 activities. SSRLAC was established on August 28, 2019, after New Hampshire Department of Environmental Services personnel proposed merging the former Saco River LAC and the Swift River LAC, which had both been defunct for several years. The initial SSRLAC committee was formed through municipal nominations from the Town of Albany, Town of Hart's Location, Town of Jackson, as well as a nominee from the U.S. Forest Service White Mountain National Forest. Over the next several months, the committee grew to include members from additional communities within the rivers' corridors, established bylaws, and began to review relevant permit applications. In addition, a partnership was formed between SSRLAC and a newly forming non-profit organization, Saco Headwaters Alliance. SSRLAC looks forward to future growth and full representation of the corridor communities of the Saco and Swift rivers. One of the major goals for 2020 will be to seek opportunities for funding the development of updated corridor management plans for both rivers. The committee will continue to provide support to relevant causes throughout Saco and Swift river corridors, review applicable permit applications, and communicate activities to member municipalities as well as the general public.

This report has been prepared in accordance with RSA 483:8-a III, which details the responsibilities of Local River Management Advisory Committees. These responsibilities are listed in RSA 483:8-a III as follows:

- a) To advise the commissioner, the advisory committee, the municipalities through which the designated river or segment flows, and municipalities within tributary drainage areas on matters pertaining to the management of the river or segment, tributary drainage areas, and disposal of state-owned lands. Municipal officials, boards, and agencies shall inform such committees of actions which they are considering in managing and regulating activities within designated river corridors.
- b) To consider and comment on any federal, state, or local governmental plans to approve, license, fund, or construct facilities or applications for permits, certificates, or licenses, that may alter the resource values and characteristics for which the river or segment is designated.
- c) To develop or assist in the development and adoption of local river corridor management plans under RSA 483:10. The local planning board, or, in the absence of a planning board, the local governing body, may adopt such plans pursuant to RSA 675:6 as an adjunct to the local master

- plan adopted under RSA 674:4. No such plan shall have any regulatory effect unless implemented through properly adopted ordinances.
- d) To report biennially to the advisory committee and the commissioner, and annually to municipalities on the status of compliance with federal and state laws and regulations, local ordinances, and plans relevant to the designated river or segment, its corridor, tributary drainage areas, and the activities of the local river management advisory committee including, but not limited to, committee volunteer hours, permit applications reviewed, corridor management plans and their implementation, and education and outreach efforts.

### **Outreach and Collaboration**

SSRLAC did not participate as a committee in public outreach efforts during 2019. The efforts of the group were primarily focused on developing membership and capacity for the basic responsibilities outlined by RSA 483. That said, multiple discussions were had about opportunities for press outreach and further involvement by the committee in community events, such as Valley Pride Day, in 2020.

The committee was successful in establishing a partnership with the Saco Headwaters Alliance and provided support to the organization for a NHDES Local Source Water Protection Grant that was awarded thereafter. SSRLAC looks forward to strengthening this relationship and those with other potential partner organizations in 2020.

# **Corridor Management Plan**

The Saco River Corridor Management Plan (CMP) and Swift River Corridor Management Plan were last updated and published in 1994. While the documents are comprehensive and accurate, they should be updated to reflect current best management practices, recent environmental trends, and modern threats to the corridors and watersheds. One of the 2020 goals of SSRLAC will be to seek opportunities

to collaborate and fund updated CMPs for the rivers, or to contribute to the development of an overall watershed management plan. SSRLAC will aim to work with NHDES, potential partners, and relevant funding entities to move toward the accomplishment of this goal.
